Transportation

The cost of transport of canoes varies depending on which river you paddle and where you wish to start. **For most hires there is no charge for transport.** For rivers further from our base this charge does not exceed 50 euros. Collection of canoes at the end of the journey is FREE. Pick up can be from an agreed point on whichever river or lake you choose to paddle (usually, the River Obra, River Notec, River Paklica or River Warta). Cars may be stored in our fenced and secure compound at your own risk. We will give your driver/s a lift back to their car/s BY ARRANGEMENT at no extra cost. We cannot undertake to return all members of your party to the start point and hirers must be prepared to make arrangements to collect extra members of their party where necessary.

Outdoor Activities are potentially hazardous, and by signing this form you accept the risk. Hire is not supervised and there is no safety cover on the water. You are entirely responsible for your own safety.

Terms and Conditions of Hire

Health and Safety.

Appropriate Health and Safety precautions are the responsibility of participants. It is the responsibility of parents/guardians, teachers or group leaders to ensure that their family or group takes appropriate precautions. Those hiring canoes should normally be able to swim. It is the responsibility of individuals to bring medication and personal items e.g. aspirins, sunscreen and insect bite cream. Participants should be aware of the existence in the outdoor environment of naturally occurring infections such as tetanus and leptospirosis, and take precautions, such as cleaning and covering abrasions, cuts and scratches occurring before or during outdoor activities, and showering after outdoor activities. If you feel unwell, even some time after outdoor activities, tell your doctor what you have been doing and where.

Personal insurance for clients is NOT included and participants take part at their own risk.

Deposit and Balance Payments.

A cash deposit of € 100 per canoe or kayak will be left and returned when all equipment is returned in good condition. Payment for canoe and/or kayak hire is required in cash and in full on the day your hire commences.

Conditions of Hire-only Bookings

1. Hire is unsupervised and is undertaken at the customer's own risk. Adventure Poland accepts no responsibility for accident or injury to the hirer or his/her party. It is the responsibility of the hirer to ensure that s/he has sufficient ability and/or experience. Those taking children on the water are responsible for the safety of their charges.
 2. Notwithstanding the above, Adventure Poland reserve the right to cancel or alter a customer's hire or to refuse hire to any group or individual. We will not issue equipment to clients who would, in our opinion, be over the legal alcohol limit for driving.
 3. The equipment should not be left unattended and may not be removed from the environs (towpath or riverbank) of the waterway for which it is hired, except on conclusion of the hire, when it should be taken to the agreed transport pick-up point.
 4. The hirer named overleaf shall be responsible for the safe return of the equipment. The hirer, or another responsible adult, shall remain with the equipment at all times it is not in use, until it is collected by a representative of Adventure Poland.
 5. The hirer shall ensure that no members of his/her party misuse or damage the equipment in any way. A deposit shall be collected and retained until such time as the Adventure Poland representative is satisfied that the equipment has been returned in a clean and serviceable condition. Where repairs or extra cleaning are necessary, a proportion or all of the deposit will be retained.
- PLEASE DO NOT USE LIFE JACKETS (BUOYANCY AIDS) AS CUSHIONS!
 - No smoking is allowed in tents nor are stoves, gas lamps or other naked flame devices to be used in the tents.
6. Children and young people under 18 must not be allowed to use the equipment unless supervised an adult.
 7. Buoyancy aids are issued as appropriate, and should be worn when on the water.
 8. The hirer shall ensure that all members of his/her party allow due consideration to other water users and the environment., and that no member of his/her party trespasses on private waterside property.
